2010 Tariffs agreed with the City of Tallinn



- Other main business revenues 45.6 mln EEK, by 2.8 mln EEK or 6.5% higher y-o-y

Costs: 9 mths 2009 compared to 9 mths 2008


Underlying cost base by 1% lower than in 1st nine months of 2008

- COGS – main operating activities by 3.0% or 5.9 mln EEK higher y-o-y, same level excluding the costs related to the Maardus operations
- Marketing costs 0.8 mln EEK lower
- Administration costs 1.6 mln EEK lower

Results impacted by the following macroeconomic indexes:

- ✓ CPI increase/decrease in 2008 +10.4%, 2009F –0.1%
 - ✓ June end CPI applicable to the tariff –0.9%
 - ✓ Real GDP decrease 2008 –3.6%, 2009F –14.5%
- Other net revenues 3.6 mln EEK lower
 - Financial costs 20.1 mln EEK higher

- Cash balances by 40.7m'EEK higher than as of 30 September 2008
